REVIEW REPORT TO THE BOARD OF DIRECTORS OF CARBO-CERAMICS LIMITED 31, CHOWRINGHEE ROAD KOLKATA-700016

- 1. We have reviewed the unaudited financial results of Carbo-Ceramics Limited (the "Company") for the quarter ended 30th June. 2017 which are included in the accompanying Statement of Unaudited Results for the quarter ended 30th June, 2017 together with the notes thereon (the "Statement").
